Mrs. Ritzler moved to appoint Amy Pugh as the new board member to replace Ryan Sieber, seconded by Ms. Lee, motion passed with five (5) ayes and no (0) nays. Mrs. Pugh will serve the remainder of the term ending December 31, 2022. The Oath of Office was given to Mrs. Pugh by Mrs. Howard.

Mr. VanDePutte moved to approve Resolution 2019-02 Filling of Vacancy on Board of School Trustees filling the seat vacated by Mr. Ryan Sieber, seconded by Mrs. Ritzler. Motion passed with five (5) ayes and no (0) nays.

Ms. Lee moved to approve and adopt the 2019-2020 Corporation School Calendar, seconded by Mrs. Ritzler. Motion passed six (6) ayes and no (0) nays.

Mr. Maes moved to approve the re-appointment of Nikki Salazar to the Starke Co. Library Board of Trustees for a term of four (4) years, seconded by Ms. Lee. Motion passed six (6) ayes and no (0) nays.

Appointment of the Discussion Team to meet with the teacher association in 2019 was tabled at the January 7th board meeting. Mr. VanDePutte moved to appoint Mr. Jones, Mr. VanDePutte, and Mrs. Pugh as Discussion Team to meet with the Teacher Association in 2019, seconded by Ms. Lee. Mrs. Ritzler moved to approve the increase to the bus drivers daily base rate from \$63.93 to \$80. We will continue to pay \$.10 a mile and \$5.00 additional to any driver who drives over 85 miles a day. The transportation secretary's hourly rate was also approved to \$10 from \$9, seconded by Mr. VanDePutte. Motion passed six (6) ayes and no (0) nays.

Mr. VanDePutte moved to approve and award the Lighting Project Selection to Trane, seconded by Ms. Lee. Motion passed six (6) ayes and no (0) nays.

Mr. Maes move to approve permission to Advertise Bus Bids through CIESC Cooperative Purchasing and was seconded by Ms. Lee. Motion passed six (6) ayes and no (0) nays. Bids will close on Monday, February 25 and the acceptance of bids will be on Monday, March 4 with buses being ordered on Tuesday, March 5.

Mrs. Howard presented the 2018 Year End Financial Report to the Board.

Mr. VanDePutte moved to approve Resolution of Transfers 2018-23, seconded by Mrs. Ritzler. Motion passed six (6) ayes and no (0) nays.
