Prices are as follows: Elementary: breakfast - \$1.65, lunch - \$2.40; High/Middle: breakfast - \$1.75, lunch \$2.50; adults: breakfast - \$1.75, lunch - \$3.00; student reduced: breakfast - 30 cents, lunch - 40 cents; extra milk: student - 35 cents; adults - 40 cents.

Jim Wentzel moved to appoint Robert Uhrich to the Fulton County Public Library Board, seconded by Chris Kline, and passed with five (5) ayes and no (0) nays.
