The board had first reading of Volume 28, No. 1 Bylaws & Policies Updates. They will have second reading and approval at the February 22 meeting.

Mr. Kitchell discussed two (2) options with the board about the Monterey Elementary School Building. The board can accept sealed bids and sell to the highest bidder or have a public auction which will require an appraisal.
