Noted the coach throwing "temper tantrums" on the sideline and the coach lacked communication with the parents. Kate Peterson noted the exceptional coaches that Culver has had in the past with their students, but expressed her concern with Coach Mosson and the lack of communication and the lack of skill, professionalism. Jamie Green questioned the board what the next step is for Coach Mosson. J.D. Uebler noted that a recommendation would be made to the board and the board will then take action based on that recommendation. Jamie noted that he would like the coach to be removed.
