Discussion/Action Items:

Mr. Behnke moved to approve 2013-03 Resolution Determining Need for Decrease in Number of Certified Staff, second by Mr. Wentzel. Mr. Schuldt shared that the Corporation has received one (1) resignation and four (4) retirements within our certified staff. Due to additional funding cuts from the State it is recommended to reduce in force (RIF) five (5) teaching positions to reach the Board's goal of reducing the budget \$500,000. The motion passed six (6) ayes and no (0) nays.

Superintendent Schuldt stated that, pursuant to the direction of the Board, he had consulted the firm of Shanahan & Shanahan LLP, bond counsel of Chicago, Illinois, relative to the procedure to be followed in connection with the proposed issuance of bonds to fund energy savings improvements at Culver Elementary School and the rendering of an opinion approving the legality of the bonds. He then presented to the Board a form of resolution approved by Shanahan & Shanahan LLP, and recommended by the Superintendent for adoption for the purpose of authorizing the issuance of bonds.

After due consideration of the preliminary bond resolution attached hereto as Exhibit A, on motion duly made by Marilyn Swanson and seconded by Ken VanDePutte, the preliminary bond resolution was adopted and is by a vote of 6-0.

On motion duly made by Dave Cooper and seconded by Edward Behnke, the Board also adopted the resolution attached hereto as Exhibit B by a vote of 6-0 to schedule the hearing on the appropriation of bond proceeds, and on motion duly made by Ken VanDePutte and seconded by Dave Cooper, the Board adopted the resolution attached hereto as Exhibit C by a vote of 6-0 to schedule a hearing on the project to be financed with the bonds.

Mr. Wentzel moved to accept a \$500 donation from the Wesley Church for the BPA National Trip, seconded by Mrs. Swanson and passed six (6) ayes and no (0) nays.

Mr. Hanselman discussed with the Board the Textbook Adoption Committee's selection process for purchasing textbooks. The Committee chose to purchase textbooks from Pearson Education at Culver Elementary for a six (6) year period.
